



## Privacyverklaring

This is the privacy statement of Yakiniku B.V.

In order to make our services available, it is necessary that we process your personal data in a number of cases. Yakiniku B.V. respects your privacy and ensures that all your personal data is treated confidentially. This privacy statement explains which data is processed, what is done with your data and what rights you have.

### **1. When and which data are processed by us?**

We process data if you:

- sign up for newsletters. This concerns the data that you yourself have provided to receive the newsletter, including at least your name and e-mail address;
- contact us (via a contact form). This concerns the data about which you contact us and which you have provided yourself to contact us. This may be your e-mail address and / or telephone number in combination with your first and last name.
- Other, namely: by filling in your details at the workshops or webshop.

### **2. Purpose of the processing**

We process personal data for various purposes, namely for:

- analytical and research purposes;
- sending news and service-oriented information to inform, interest and engage you;
- compliance with legal obligations.

Insofar as legislation and regulations impose further requirements on the processing, such as requesting permission in advance, offering the right to object or being able to deregister afterwards, we will of course follow those requirements.

### **3. Provision to third parties**

The data collected by us is necessary for the purposes described above. If provision of the data to third parties is necessary for the execution of the aforementioned purposes, we will make your data available to these third parties under the conditions set by us and in line with the applicable legal requirements and guidelines. This concerns, for example, the provision of data to third parties who offer an ICT solution.

### **4. Retention period**

The personal data is only processed for the purposes stated above. We do not store your personal data for longer than is necessary for the processing of the purposes described above, unless this data is necessary to comply with a legal obligation.

### **5. Security**

We handle the processing of your data with the utmost care. We constantly take appropriate measures to protect your data against loss, unauthorized use or alteration. These measures are in line with the applicable legal requirements and guidelines.

Privacy statement - visit website

In order to make our website and the related services available to users, it is necessary that we process personal data in a number of cases. We respect the privacy of users and ensure that all your personal data is treated confidentially. This privacy statement explains exactly which data is processed, what is done with your data and what rights you have.

### **Which data are processed by us?**

[Note: it is important to check whether or not you use analytical cookies with consequences for the privacy of website visitors. The data processed by us consists of two categories: On the one hand, these are data that you enter yourself in forms on the website. This information concerns your identity (such as name, address, e-mail, etc.) as well as information related to the question or service you have asked for.

In addition, we use Google Analytics for statistical purposes, a web analysis service provided by Google Inc. ("Google"). Google Analytics uses "cookies" (text files placed on your computer) to help the website analyze how users use the site. The information generated by the cookie about your use of the website (in the case of Yakiniku BV without your IP address) will be transferred to and stored by Google on servers in the United States. Google uses this information to keep track of how you use this website, to compile reports on website activity for the owner of this website.

Yakiniku BV has concluded a processor agreement with Google. We masked the last octet of the IP address and turned off data sharing. We also do not use other Google services in combination with the Google Analytics cookies.

If you object to this form of data recording, you can set your browser so that it does not accept cookies. However, not accepting cookies may prevent you from accessing some pages of this website.

We do not analyze personal data nor are it further processed by us.

### **What do we do with your data?**

The purpose of processing the data is:

- Processing your question.
- Enable us to provide our services.
- Promoting the user-friendliness of the site.
- Being able to make offers and promotions or provide information or news bulletins relevant to you (only with your consent).

The personal data is only processed for the above purposes. We do not store your personal data for longer than is necessary for the processing of the purposes described above, unless this data is necessary to comply with a legal obligation.
